Until such time the kennel will be considered to be a licensed kennel or a kennel operating under license suspension as set forth in Part IV, paragraph 5 of this Closure of Kennel Application and the Department may continue to do unannounced inspections. Those inspections may be prior to the date listed in this closure application and do not constitute the post closure inspection. Operating a kennel without a license

constitutes a violation of sections 206 and 207 of the Dog Law (3 P.S. §§ 459-206 and 459-207) and will subject applicant(s) to any and all criminal and civil penalties and fines available to the Department for such violation. Therefore, applicant(s) is obligated to have reduced the number of dogs in the kennel for which this closing application is filed to 25 or less by the time of the Department's post closure inspection or applicant(s) will be operating a kennel without a license, which is illegal in the Commonwealth of Pennsylvania.

C.S. § 4904, that all information contained in this application and any attachments and supporting material is true and correct; applicant(s) is authorized to execute this Closure of Kennel application on behalf of the above listed kennel operation, and hereby consent(s) to the entry of this Closure of Kennel application; and hereby knowingly waive(s) any right to a hearing under the Pennsylvania Dog Lāw (3 P.S. § 459-101 *et seq.*, which is the statute that controls this action, and knowingly waive any right to appeal the filing of this Closure of Kennel application or actions taken by the Department resulting from the filing of this Closure of Kennel application, which rights may be available under Sections 7 or 11 of Act 119 of 2008, known as the Dog Law (3 P.S. § 459-207(a.3) and (e) and 459-211(b)); The Administrative Agency Law, 2 Pa. C.S. § 103(a) and Chapters 5A and 7A, or any other provision of law; and that applicant(s) is aware of, understand(s) and agree(s) to abide by the following:

- 1. Operating a kennel without a license constitutes a violation of sections 206 and 207 of the Dog Law (3 P.S. §§ 459-206 and 459-207) and will subject applicant(s) to any and all criminal and civil penalties and fines available to the Department for such violation.
- 2. The filing of this Closure of Kennel application constitutes a voluntary surrender of applicant(s) Pennsylvania Kennel License or a voluntary failure to renew applicant(s) Pennsylvania Kennel License in a new calendar year and that without a current Pennsylvania Kennel License applicant(s) may not continue to operate a kennel in the Commonwealth of Pennsylvania.

- 3. This Closure of Kennel application will become effective upon the date of the Department's post closure inspection and issuance of a certificate of closure, which shall occur subsequent to the date set forth by the applicant in Part II, paragraph 1. of this application. Therefore, applicant(s) is obligated to have reduced the number of dogs in the kennel for which this Closure of Kennel application is filed to 25 or less, or applicant(s) will be operating a kennel without a license, which is illegal in the Commonwealth of Pennsylvania.
- 4. The failure to comply with the requirements set forth in paragraph 3. above will result in the issuance of a cease and desist order from the Department and applicant(s) may be cited for operating a kennel without a license and subject to all criminal and civil penalties and fines, and forfeiture of dogs, if applicant(s) continues to operate a kennel after the effective date of this Closure of Kennel Application.
- 5. The kennel listed in this application will continue to be a licensed kennel and subject to all applicable kennel requirements of the act and regulations, including unannounced kennel inspections, as well as all penalties allowed under the Dog Law, until the time of closure set forth in this Closure of Kennel application and the performance of the post closure inspection by the Department, unless the kennel license automatically expires because of the end of a calendar year. If such automatic expiration occurs prior to the closure date of the kennel listed in this Closure of Kennel application, the kennel shall be considered to be operating under a suspended license and subject to the provisions of section 211(c)(1) of the Dog Law (3 P.S. § 459-211(c)(1)).
