

COMMERCIAL FEED AND INGREDIENT REPORT

Instructions: See explanation of the PA Commercial Feed Ingredient Report

Definitions:

Guarantor – The company whose name appears on the label of a feed.

Customer-Formula Feed – A commercial feed, each batch of which is manufactured according to the specific instructions of the final purchaser. The labeling for this feed must include the name and net weight of each ingredient used in the mixture (the formula).

Complete Feed – A feed that can be fed as the sole ration without further mixing.

Supplement – A feed used with another to improve the nutritive balance (includes concentrates and premixes).
