



- No 1: Found recorded for another prior to receipt of application.
- No 2: Found conflicting with other recorded brands.
- No 3: Single letter or figure not acceptable.
- No 4: Remittance did not accompany application. Please make checks payable to the Commonwealth of Pennsylvania.
- No 5: All information requested should be supplied.
- No 6: When brands for domestic animals are on the same location, only one fee shall be charged; but when different, separate fees shall be paid.
- No 7: Names of persons in firm or partnership registration are required and should be shown.
- No 8: Sale or Assignment of Brand- Any brand recorded shall be the property of the person causing such record to be made and shall be subject to sale, assignment, transfer, devise, and descent as personal property. Instruments of writing, evidencing the sale, assignment, or transfer of such be recorded by the secretary and the fee for recording such sale, assignment, or transfer shall be five dollars (\$5.00).
