Overview

The Pennsylvania Department of Agriculture has been charged with enforcing the commonwealth's Dog Law since 1966. Few areas of the department have remained as they were in the 1960's, and the issues and businesses related to dogs are no exception. Through the efforts of Governor Edward G. Rendell and the Pennsylvania Department of Agriculture, the Bureau of Dog Law Enforcement has moved forward to serve our commonwealth's citizens and dogs. The effort to improve dog law enforcement started in late 2006, with a focus on enforcement, training and outreach under existing law. These efforts progressed from 2007 through the Fall of 2008 to include an intensive effort to craft, garner support for and pass an improved and updated Dog Law, and continues to move towards full implementation of this law.

There are a variety of reasons for the many new faces, protocols and policies of the Bureau of Dog Law Enforcement since 2006. A changing kennel landscape forced a review of the different sectors regulated through the Dog Law; recognition that staffing decisions must mirror the changing demographics of the dog industry; an awareness of the limitations of existing processes and laws; and an opportunity to recruit, train and deploy persons knowledgeable about both law enforcement and dogs. Most importantly, a moral mandate to better protect the dogs in Pennsylvania drove these changes.

Many changes have occurred since 2006, but most significant was the 2008 passage of Act 119, an overhaul of the Pennsylvania Dog Law that raised the bar for commercial breeding kennel owners, and transformed this law into the most progressive in the nation. This was a joint effort by the legislature and administration, with an uncommon amount of input from both interest groups representing every segment of the dog world, and the general public. The treatment of dogs in kennels is something Pennsylvanians care deeply about, and citizens made their views known throughout the legislative process. The breeding, training, showing, and enjoyment of dogs has been enhanced by this new law.

The Department of Agriculture is proud that, in 2008, the Bureau of Dog Law Enforcement was able to more fully enforce the Dog Law, and to use these experiences to advocate for changes that would improve the law's ability to protect kenneled dogs and support the quality of licensed kennels in the commonwealth.

Enforcement highlights from 2008 include:

- Launched Web site form and toll-free tipline – 1-877-DOGTIP1 - for complaints and tips.
- Seizure of 98 dogs under the Dog Law, and various other seizures by local humane societies contacted by the bureau to investigate cruelty or neglect.
- Formally revoked 14 kennel licenses, including the first out-of-state dealer license revocation based on a cruelty conviction, and six licenses surrendered as a condition of enforcement actions.
- Increased citations issued by 30%, as some kennel owners continued to present substandard conditions after warnings, and dog license canvassing resumed.
- Overhauled rabies vaccination self-certification process to ensure proper training and recording.

Dog Law Background

While the Pennsylvania Dog Law was formally linked to the Pennsylvania Department of Agriculture in 1966, the current Dog Law regulations that the department enforces were written in 1982. As can be imagined, mandates from the early 1980's are dated, and no longer applicable to today's kennels.

In 1996, Pennsylvania's Dog Law was revisited. While changes were made, including the banning of dog auctions, the law still suffered from vague language that hindered enforcement. It treated all types of dog breeding businesses the same, regardless of size or function, and could not adequately address the conditions in Pennsylvania's commercial breeding kennels. Activities that did not exist in 1996 - such as dog day care, rescue network kennels and internet selling - were common by 2008.

The need for new laws led to the successful crafting of House Bill 2525, an overhaul of the Dog Law that gained a broad consensus of support. This bill, now known as Act 119 of 2008, was circulated in preliminary draft for comment in December 2007, introduced in early May 2008 and signed into law by the Governor on October 9, 2008.

Passage of Act 119 of 2008

The new Dog Law defines commercial breeding kennels, so that minimal standards for these kennels are increased without adversely impacting other types of kennels. The goal of the new legislation was to close the gap between what was legal and what was humane in these unique kennel settings. Commercial kennels are those breeding kennels that sell to dealers or pet stores, or sell or transfer more than 60 dogs a year.

The new law provides the breeding dogs with doubled minimum cage sizes, the opportunity for outdoor exercise in an area twice as large as their cage, routine veterinary care including a written program of care and two examinations each year, and solid or slatted "kennel deck" flooring so they can move normally within their cages and without injury to their feet and legs. The provisions in the new law protect them from extreme heat and cold, mandate that water be available at all times and prohibit stacking of cages for adult dogs. The act allows these dogs to be euthanized only by a veterinarian. Construction and sanitation control standards are set that mirror USDA regulations and, often, current Pennsylvania regulatory standards. The sections of the law that apply only to commercial kennels will take effect on October 9, 2009.

For other types of kennels, Act 119 has a few additional requirements. All kennels must have an exercise plan approved by a veterinarian, have fire extinguishers or smoke alarms, display their kennel license, sell puppies at a minimum age of eight rather than seven weeks consistent with USDA, and refrain from buying from unlicensed out-of-state dealers. Current regulations for these kennels remain in place and are not expected to be changed.

Act 119 raises minimum fines for unlicensed dogs and raises maximum fines for some violations from \$300 to \$500. The Act does not raise licensing fees. The act increases the minimum fines for unlicensed dogs from \$25 to \$50, the penalty collected by municipalities from owners to redeem a licensed dog found running at large from \$15 to \$50, and registration for a dog that has been found by a court to be a dangerous dog is raised from a \$200 one-time payment to \$500 per year. Dangerous dogs must also be spayed/neutered and micro-chipped to provide increased public protection.

Enforcement provisions in the new law give the Bureau of Dog Law Enforcement tools to deal with situations it could not under former law. The law creates a mandatory loss or refusal of license if the

kennel owner or applicant has been convicted of animal cruelty within the past ten years, or earlier if there is evidence that person has not been rehabilitated. The new Dog Law also adds additional grounds for revocation, including violations of the Rabies Law or Dog Purchaser Protection Act (Puppy Lemon Law), felony convictions, a final denial of zoning to operate a kennel at the location, and prior license revocations.

Creation of the Canine Health Board is an innovative solution to obtain the necessary expertise to establish certain specific commercial kennel requirements. This volunteer board of nine veterinarians appointed by the Governor, legislature, Pennsylvania Veterinary Medical Association and University of Pennsylvania School of Veterinary Medicine met six times in November and December of 2008 to develop temporary guidelines for auxiliary ventilation if the air temperature is 85 degrees or higher; ventilation, humidity, ammonia and lighting ranges; and additional flooring options beyond solid and slatted flooring. The board's guidelines will be promulgated as proposed regulations through the regulatory review process during 2009, and will continue to make case-by-case determinations on exercise plan alternatives to the law's prescribed free access to an outdoor area.

Miscellaneous provisions of the new Dog Law create a separate seat on the Dog Law Advisory Board for a representative of boarding kennels, and increase the board's statutory complement from 16 to 24 members. The new law also provides for additional warden training in the areas of biosecurity, breed and use variability, and investigation and prosecution of animal cruelty; mandates two kennel inspections each year to conform to existing bureau practice; and prohibits wardens from carrying firearms on the job. It clarifies that dealers within the commonwealth, dog day cares and rescue network kennels and their "foster" homes fall within the law.

This legislation was intensively supported by the Bureau of Dog Law Enforcement through testimony given before the House and Senate Agriculture and Rural Affairs Committee, hundreds of legislative and interest group meetings, nine town hall presentations, two capitol rallies, three presentations at annual meetings of interest groups, three Dog Law Advisory Board meetings devoted to this topic and including public comments, the creation of a Dog Law Action website with e-mail signup for legislative updates, numerous draft revisions and the analysis of more than 100 amendments.

Implementation of Act 119

The first step in implementing the new Dog Law began immediately, as bureau employees placed calls to more than 1,400 kennel owners to inform them that, if they were defined as commercial kennels, they could only have their dogs euthanized by a veterinarian, and could not shoot or otherwise euthanize them, effective immediately. Letters were then sent to kennel owners in October 2008 detailing the new law, its timelines and how it would affect them. Bureau forms were rewritten or revised, including the kennel license application and all dangerous dog forms, and new forms such as commercial kennel waiver applications were needed. Kennel applications for 2009 have required extensive processing, including criminal background checks.

To expedite the 2009 kennel license cycle, the bureau dedicated one full-time employee, plus others as needed, to answer phone calls from kennel owners. The bureau hosted two workshops on the new kennel application in December 2008, each attended by more than 100 persons, and created a frequently asked application questions document on the Department of Agriculture Web site. Employee training on the new law took place on November 13, 2008. The bureau continues to provide timely, accurate information to dog and kennel owners. The bureau has also replied to an unprecedented number of e-mail inquiries through the Department of Agriculture's Web site contact

form. During November and December 2008, the bureau also provided extensive administrative support to the Canine Health Board.

Bureau of Dog Law Staffing, Training and Quality Control

The Bureau of Dog Law Enforcement employs 62 state dog wardens, including six supervisors and four kennel compliance specialists who form teams to focus on larger kennels, non-compliant kennels and illegal, unlicensed kennels. In 2008, the bureau assigned a warden to become the first dangerous dog coordinator. The coordinator's duties are to contact municipalities and courts to update our dangerous dog registry, to ensure all requirements for these dogs are being met, to find violators who have moved or sold the dangerous dog without notification, and to inspect dangerous dogs and assist wardens statewide with these specialized cases. A map detailing the location of Dog Law wardens, supervisors and kennel compliance specialists is included as Appendix A of this report.

On an annual basis, six kennel quality control spot checks for each warden are now conducted by supervisors without notice to the warden. Rotation of dog wardens to inspect commercial kennels in counties to which they are not assigned was implemented for the second round of kennel inspections in 2008. The PADogs software program has been modified to reflect the changes to inspections and record keeping brought about by Act 119.

After a nationwide search, several veterinarians were interviewed during 2008 as candidates for the Bureau of Dog Law Enforcement's first veterinarian. This process resulted in the hiring of two per diem veterinarians with extensive dog and some kennel experience, one of whom will move to permanent status in September 2009. With these veterinarians on board, the bureau's ability to assess and monitor dog health will be greatly enhanced. Meanwhile, during 2008, veterinarians from the Bureau of Animal Health and Diagnostic Services assisted with kennel inspections related to revocations and with problem kennel investigations. Kennels that appealed their license revocations were checked frequently to ensure the health of the dogs while they remained open.

The bureau provided extensive training to employees during 2008:

- Biosecurity procedures were reviewed and demonstrated, and supplies distributed.
- Dog Law Prosecutor provided training on regulations within the Dog Law, how to prove cases in court, and effective citation writing.
- Management, supervisors and local wardens attended the Federated Humane Society's Annual Conference in October 2008, where topics included rabies, dog handling, utilizing a veterinarian as an expert witness and Act 119 of 2008.
- Management and supervisors attended the Pennsylvania Veterinary Medical Association Annual Conference in August 2008, which included sessions on dog health and welfare in large kennel settings, specific dog diseases and dog handling.
- Humane Society Police Officer training was provided to wardens - Part I (criminal law and procedure and cruelty statute), Part II (hands-on animal health training at Penn State University) or the continuing education session for those who had completed Parts I & II. By June 2009, all wardens and supervisors will have taken both parts of this training.
- Dog Law prosecutor provided training to wardens and Humane Society Police Officers at the Federated Humane Society continuing education session in May 2008. Topics included how to execute cruelty citations, write a search warrant, and work with expert testimony.
- Tour of University of Pennsylvania School of Veterinary Medicine and Philadelphia City Pound (PACCA) held November 14, 2008 - all wardens and supervisors were trained by two University of Pennsylvania veterinarians on recognition of dog pathology and behavior issues.

2008 Bureau of Dog Law Enforcement Activities – Reporting Mandate

Section 906 of the Dog Law includes a call for the Department of Agriculture to share with the Pennsylvania General Assembly a report outlining relevant activities related to the Bureau of Dog Law Enforcement. The actual language of the report requirements is set forth below, and calls for 11 data points that can be used to gauge the performance of the bureau and the work being done across the commonwealth. Detailed numbers or charts for each of the requested data points are included in this report. The location of each chart will be noted as it is discussed in the narrative below.

The information required by Section 906 includes:

License Metrics

Dog licensing in Pennsylvania serves a variety of purposes. The tracking of licenses gives Bureau of Dog Law Enforcement personnel insight into the total universe of the dog population in Pennsylvania, provides dog owners with a tracking mechanism to help reconnect with lost dogs, and financially supports the work done across the commonwealth to protect dogs and regulate the dog industry.

Dog licenses in Pennsylvania are sold through the 67 county treasurers. Revenues collected from the sale of annual and lifetime licenses go into the Dog Law Restricted Fund. Philadelphia County and the cities of Harrisburg, Altoona, Erie, Pittsburgh and Scranton have their own dog licensing programs and, as such, handle the licensing process and retain licensing revenues. For this report, the total numbers of licenses includes counties where these cities are located (except the county of Philadelphia, congruent with the city), but the revenue numbers do not reflect the moneys kept by these cities. Full metrics on licenses issued in 2008 can be found in Appendix B of this report.

Dog Licenses

In 2008, there were 929,445 individual (annual and lifetime) dog licenses issued, generating \$5,648,918 in revenue. In 2007, there were 918,004 such dog licenses issued, generating \$5,563,449 - dog license sales and revenue increased by 1.5 percent. Two-thirds of the 67 Pennsylvania counties increased their license sales at least 1 percent from 2007.

Erie County (not including the City of Erie) increased its license sales in 2008 to 19,649, 143 percent of its 2007 sales, and Allegheny County sold the most licenses at 99,944.

Kennel Licenses

A kennel must be licensed if they have 26 or more dogs during the course of a year. The bureau licensed more than 2,674 kennel locations in 2008, resulting in revenues of \$491,000. A full listing of kennel license numbers can be found in Appendix C. It is important to note that prior to any kennel licenses being issued, Bureau of Dog Law Enforcement personnel complete site visits and inspections to ensure that the kennel is compliant with the Dog Law and regulations. The department also conducted its first kennel survey in 2008 to learn specifics about each kennel's purpose – the response rate was more than 80 percent and the survey results are included as part of Appendix B.

Of the 2,674 kennels licensed in 2008, Lancaster County was home to 299, comprising approximately 11 percent of the total kennels in Pennsylvania. This included 84 kennels licensed to have more than 250 dogs. Bucks County had the most licensed kennels with fewer than 51 dogs; Allegheny, Chester and York Counties had the most boarding kennels, and Montgomery County was home to the most non-profit kennels.

Out-of-State Dealers

The bureau licensed 49 out-of-state dealers in 2008 - a 25 percent increase over 2007 levels (39 dealers licensed) and nearly a 90 percent increase over 2006 levels (26 dealers licensed). This generated \$29,225 in revenue. This growth has been fueled by the bureau sending letters to apparent out-of-state dealers to educate them on the commonwealth's licensing requirements.

Dog Law Inspection and Enforcement Activities

The PADogs software program, initially rolled out in January 2007, supports the work that is done in the field by the dog wardens and kennel compliance specialists who complete the inspections. Regulating the nearly 2,700 kennels and more than 800,000 kenneled dogs in Pennsylvania requires a mobile, field-based staff that is able to support kennels and dog owners as they strive to meet the law, as well as enforce sanctions against those who do not. Many enhancements were made to PADogs and PADog Warden (an offline version of the system with upload capabilities used by field staff) in 2008, including various changes to meet the mandates of Act 119.

Steps were taken in 2008 to resolve connectivity issues for wardens in remote areas. The bureau also created a software focus group to streamline the PADogs data system, including management, information technology and contractor representatives as well as knowledgeable users from each region. The first meeting resulted in the rollout of an update, and further focus group sessions are planned.

Increased effort to enforce out-of-state dealer license requirements bore fruit with 49 out-of-state dealers registered in 2008, up from 26 in 2006. All 2008 kennel applicants were sent a list of licensed out-of-state dealers for reference, and this information was placed on the department Web site.

Licensed kennels in 2007 that did not renew for 2008 were checked during February and March 2008 to see if they had closed, restructured or were operating illegally. The bureau continued its practice of informally sharing information with the U.S. Department of Agriculture on kennels inspected by both – there are 250 USDA licensed kennels in Pennsylvania, representing commercial dealers and breeders who sell wholesale. The bureau also worked with local authorities on zoning and other topics of interest.

Also in 2008, the Department of Agriculture’s Dog Law prosecutor completed presentations of continuing education courses in Dog Law to all magisterial district judges across the commonwealth.

Kennel Inspections and Number of Dogs

A total of 6,033 kennel inspections were completed in 2008. The bureau continued to inspect every licensed kennel twice a year – going beyond the annual inspection required by Section 218 of the former Dog Law. Section 218 has been revised by Act 119 of 2008 to require twice-a-year inspections. The bureau also committed to re-inspect unsatisfactory kennels within approximately two weeks, and to require that two dog wardens be on site to inspect all kennels (other than pet stores) with a license to keep more than 150 dogs per year. These commitments stem from the recognition that a 12 month inspection cycle could create windows where unsatisfactory conditions may exist without the knowledge of bureau personnel, and a concern that a lack of immediate follow-up with non-compliant kennels could allow unhealthy situations to continue while dogs suffer. The bureau also developed an abbreviated kennel checklist form to be given to the kennel owner at the time an inspection occurs, with a check box for each category on the inspection report, in advance of mailing the official report.

On 2008 kennel applications, kennels reported the following numbers of dogs kept and sold/adopted:

Kennel License Terminations, Including Refusals, Revocations and Suspensions

There were 256 kennel licenses and one out-of-state dealer license terminated in calendar year 2008. The majority of these kennels closed voluntarily or relocated, with some closing to avoid pending or potential enforcement action by the Bureau of Dog Law Enforcement.

The bureau formally revoked or refused 14 of these kennel licenses – counties involved were Beaver, Berks, Bradford, Chester, Fayette, Lancaster, Lehigh, Mercer, Snyder, Sullivan and Union, and the state of New Jersey. Six other licenses were surrendered as a condition of an enforcement action – counties involved were Adams, Berks, Chester, Lebanon, Union and York. The bureau revoked, refused or sought these licenses based on animal cruelty convictions or Dog Law violations stemming from unsatisfactory kennel conditions.

In 2008, the bureau continued to work with kennels on a case-by-case basis to create a structure allowing a kennel to receive a conditional license after creating agreed upon inspection, improvement or fine structures to ensure animal welfare was not compromised while the kennels came into compliance. This was done on a limited, strictly enforced basis to maximize compliance with the law.

The bureau filed seven injunction actions in county Common Pleas Courts and in the Commonwealth Court of Pennsylvania against illegal, unlicensed kennels that continued to operate – counties involved were Cambria, Lancaster, Tioga and Warren. In December 2008, the bureau seized 98 endangered dogs from a Lancaster County kennel after a permanent injunction was granted against the kennel,

which had continued to operate despite cruelty convictions and a license revocation based on appeals filed.

Various enforcement actions were coordinated between the bureau and local humane society police officers during 2008 in which dogs were seized by or surrendered to humane police officers because of cruelty or neglect. Six focused on licensed kennels in Berks, Chester, Lancaster, Lehigh and Sullivan Counties. Dogs from several illegal, unlicensed kennels were also seized by or surrendered to humane society police officers in Lancaster and Dauphin Counties.

Citation Issuance

In 2008, 5,655 summary citations were issued, as well as 53 misdemeanor charges. These numbers include both kennel condition citations and citations for other violations of the Dog Law, including but not limited to failure to license, dogs running at large or abandoned, and dangerous dogs. There were 48 citations issued in 2008 for operating unlicensed kennels, compared to 50 in 2007 and 6 in 2006. The efforts of the bureau to do a systematic check of those operations not renewing their license brought some of these kennels to light. There were 182 kennel citations for unsanitary or inhumane conditions and 89 for various records violations including 69 for rabies vaccination records. A full list of the citations issued by county is included in Appendix D of this report.

Dogs Seized and Impounded and Total Related Reimbursements

In Pennsylvania, the Bureau of Dog Law Enforcement also plays a critical role in managing stray dogs. Currently, there is a provision setting holding and disposing fees for these dogs at \$20 per dog by Section 25.1 of the Dog Law regulations. The bureau covers this \$20 per dog fee, sending the money to the local entity that handles the stray once it is picked up. Statewide payments for stray dogs were \$333,140. This amount will be raised to \$30 per dog in 2009. This data can be found in Appendix E.


The statutory term “dogs seized and impounded” is somewhat misleading, as there are separate dog seizure provisions in the Dog Law (a dog can be seized from kennels when the license has been revoked or refused, or illegal unlicensed kennels, if the dog’s health, safety or welfare is endangered). Prior to 2007, dogs had not been seized under this provision for many years, if ever. In 2008, the bureau – as a part of its stronger enforcement of existing law – seized 98 dogs from a kennel in Lancaster County after seeking and obtaining an injunction to close the kennel.

Dog Law Financial Reports

The Bureau of Dog Law Enforcement sees a number of funds coming into and out of the restricted fund that sustains the bureau – no tax dollars are used to fund the bureau. This money is kept separate from other Department of Agriculture general funds to better track the moneys coming in from dog and kennel licenses and manage the funds being sent out to local shelters and industry organizations. Information is provided below on 2008 bureau financials, and a detailed financial statement is included in Appendix F of this report.

Licensing Fees

In 2008, \$6,169,143 was collected in licensing fees. This number consists of individual dog licenses, kennel licenses and out-of-state dealer licenses. A chart is included below showing the total contribution from each license segment.



In addition to the money generated through licensing, the bureau received \$69,173 from fines and penalties (the amount the bureau receives is capped at this amount by Act 64 of 1987) and \$12,234 from miscellaneous fees. Other income of \$477,572 came from interest on existing balances in the restricted fund, less than half of the \$1,022,118 earned in 2007.

Dog Law Restricted Fund Payments

Payments are made from the Dog Law Restricted Fund as a part of normal operating procedure, covering the costs of bureau staff, operating expenses, equipment and fixed assets and the money given to entities such as humane societies that shelter and sometimes pick up stray dogs.

The payments from the Dog Law Restricted Fund in 2008 were:

The ending balance of the fund on December 31, 2008 was \$12,840,976, down from \$14,156,278 on December 31, 2007.

Domestic Animal Damage Claims

The Bureau of Dog Law Enforcement pays claims for damage to domestic animals. In 2008, these expenses were \$5,994 for damages done by coyotes. Act 119 of 2008 increased this damage cap from \$20,000 to \$75,000 in Section 706(i) of the Dog Law, and provides that claims exceeding the cap roll over to be paid the following year), and \$20,712 for damages by dogs (there is no cap for this payout). In 2008, there were a total of 145 coyote claims and 156 dog claims. This information is found in Appendix G of this report.

Recommendations and Plans for 2009

The Department of Agriculture, through its Bureau of Dog Law Enforcement, takes very seriously its role as the enforcer of Pennsylvania's Dog Law. Yet even the most extraordinary efforts on the part of the bureau to regulate the dog industry in Pennsylvania could not compensate for a Dog Law that did not reflect current business practices or provide adequate enforcement tools. In 2008, a new Dog Law changed and brightened this picture, while supporting Pennsylvania's many dog professionals and enthusiasts in their businesses and pursuits.

In 2009, the bureau will take another large stride forward professionally with a dedicated bureau veterinarian. The implementation of Act 119, done quickly in 2008 by necessity, will be refined and streamlined to help dog and kennel owners fully understand and follow the new law. Online dog license sales will be explored. Assisting animal shelters perform their core mission of animal cruelty investigation and prosecution, as well as partnering with the bureau to take stray dogs, will be key in this challenging economy. The DogLawAction.com Web site used to promote Act 119 prior to its passage will be redesigned in 2009 as a source of news about the bureau's work.

Summation



These changes befit a state with thousands of kennels and millions of dogs. The teamwork of a special deputy secretary and bureau director committed to the welfare of dogs and to prompt and knowledgeable interaction with the many publics served, a prosecutor managing legal cases, a veterinarian providing expertise during kennel inspections and training, a team of specialists to inspect large and problem kennels, and sharp and dedicated county wardens and supervisors throughout the commonwealth has created a new paradigm for the enforcement of the Dog Law.
