

**STATE HORSE RACING COMMISSION  
(License Fee Schedule)**

The State Horse Racing Commission (Commission), by and through its Bureaus of Standardbred Horse Racing and Thoroughbred Horse Racing, hereby establishes a revised fee schedule for the issuance of occupational licenses. This license fee schedule is issued under authority granted to the Commission by Article XXVIII-D, Sections 2812-D (3) and 2823-D of the act of February 23, 2016 (act 7 of 2016), which amended The Administrative Code of 1929 (P.L. 177, No.175) (“Racing Act”).

The Act requires the Commission to license trainers, drivers, horse owners, vendors, persons participating in horse race and all other persons required to be licensed as determined by the Commission (Section 2823-D (a)). Licenses shall be issued for a three-year term. Only new and renewal applicants for an owner’s license may omit the picture requirement unless entering the stable area.

Where necessary or applicable, the Commission consolidated the license classifications and all previously established occupational license fees issued prior to February 23, 2016. The Commission shall no longer distinguish license classifications by horse breed. The Commission approved the license fee schedule at its public meeting on June 29, 2016 and directed that the schedule be published in the *Pennsylvania Bulletin* as soon as possible. All new fees shall take effect as of July 1, 2016, and supersede the previous fee schedules individually approved or issued by the former State Horse and State Harness Racing Commissions respectively.
