AND NOW, this 26th day of March 2019, the Commission hereby ratifies and adopts the Interim Order and Annex A issued by Acting Director Chuckas on March 12, 2019 which amended an inconsistent provision in the Commission's existing standardbred regulations at 58 Pa. Code §185.163 (h) (relating to sale of pari-mutuel tickets) as a temporary regulation. §185.163. Sale of pari-mutuel tickets.

* * *

(h) No pari-mutuel ticket shall be sold for less than \$2.00, **except with specific approval by the Commission.** No pari-mutuel ticket combining Win and Place, Win and Show or Place and Show, shall be sold for less than \$4.00, **except with specific approval by the Commission.** No pari-mutuel ticket combining Win, Place and Show shall be sold for less than \$6.00, **except with specific approval by the Commission.**

(This temporary regulation specifically modifies 58 Pa. Code §§185.163 (h) of the existing harness regulations.)



INTERIM ORDER

AND NOW, this 12th day of March 2019, in accordance with the specific authority and duties delegated to the Acting Director of Standardbred Horse Racing by the January 28, 2019 Order (Admin. Docket No. 2019-3), upon consideration of the requests made by management of the Meadows Racetrack & Casino and the Pennsylvania Harness Horsemen' Association to immediately amend an inconsistent provision in the Commission's existing regulation at 58 Pa. Code §185.163 (h) (relating to sale of pari-mutuel tickets), the Bureau of Standardbred Horse Racing hereby adopts the following temporary regulation providing for an exception to the regulation with specific approval by the Commission, as set forth in the attached Annex A.

This Interim Order shall take effect upon execution by the Acting Director of the Bureau of Standardbred Horse Racing and shall be subject to review and ratification by the Commission.
