Public notice of the February 4, 2015 Pennsylvania Wine Marketing and Research Program Board meeting was given on January 29, 2015, as stipulated by the Sunshine Law.

#### **CALL TO ORDER**

Mario Mazza, Chairman, called the meeting to order at 10:08 a.m. Board members in attendance (in addition to Mr. Mazza) included Bradley Knapp, John Landis, Joanne Levengood, Douglas Moorhead, Elwin Stewart and Karl Zimmerman. Bryan Hed, The Pennsylvania State University, and Jody Timer, Lake Erie Regional Grape Research and Extension Center, participated in the meeting via conference call. Acting Secretary Russell C. Redding and Brook Duer, Pennsylvania Department of Agriculture attended a portion of the meeting.

#### 2015-2016 RESEARCH, MARKETING AND EDUCATIONAL PROPOSALS

Proposals for wine research, marketing and education for 2015-2016 (April 1, 2015 – March 31, 2016) funding consideration were reviewed. The following proposals were considered:

#### **FINANCIALS**

Mr. Landis reviewed the prepared financial reports for July 1, 2014 – June 30, 2015. Mr. Landis stated that the projected income was \$124,356.25, and total marketing and enology and viticulture research budget was \$57,936.07. Ms. Belles informed the board of errors on the financials: cash carryover date needs to be changed from 01/30/2015 to 07/01/2014; cash carryover amount needs to be changed from \$388,313.70 to \$263,957.45; the funds available currently listed as \$512,669.95 is incorrect – the correct amount is \$388,313.70. Ms. Belles will make the corrections and send an updated financial report.

Invoices need to be submitted for projects listed on the financials showing \$0 paid. Mr. Landis stated that the Program just received an invoice from Penn State for Dr. Crassweller's project, Maintenance of Wine Grape Cultivar Trials in PA, for the fiscal year July 1, 2012 – June 30, 2013. Mr. Knapp stated that no information has been received from Dr. Crassweller regarding his projects.

#### ASSESSMENT REPORTS

Ms. Snyder reviewed the Summary of Assessment Forms 2014 Year-To-Date. As of January 29, 2015, \$194,110.28 has been collected from Pennsylvania wineries. There were 283 licensed wineries, 109 licensed wineries with no sales assessments reported, 174 producers with sales assessments and the number of producers paid was 178.

Ms. Snyder then reviewed the Assessment Income Analysis by Quarter. In the first quarter of 2014, \$51,054.63 was received; \$34,033.90 was received in the second quarter, \$42,569.70 was received in the third quarter, and \$66,452.05 for the fourth quarter for a total of \$194,110.28 collected. \$39.65 was received so far in the first quarter of 2015.

There was no new information to report regarding delinquents. The Department will obtain the 2013 limited wineries gallon report from the PLCB in April.
