CALL TO ORDER

FINANCIALS

Ms. Belles reviewed the prepared financial reports for July 1, 2015 – June 30, 2016. Ms. Belles stated revenue year to date is \$252,662.15, cash carryover from July 1, 2015 is \$234,743.33; expenses are \$289,788.71; cash funds available as of June 30, 2016 is \$197,616.77.

Ms. Belles will reach out to Garcia, Garman and Shea, PC to start the audit process.

ASSESSMENT REPORTS

Ms. Sheffield reviewed the Summary of Assessment Forms 2016 Year-To-Date. As of July 1, 2016, \$43,779.86 has been collected from Pennsylvania wineries. There were 333 licensed wineries, 176 licensed wineries with no sales assessments reported, 157 producers with sales assessments and the number of producers paid was 120.

Ms. Sheffield then reviewed the Assessment Income Analysis by Quarter. In the first quarter of 2016, \$27,052.92 was received and so far \$16,726.94 was received in the second quarter for a total of \$43,779.86 collected.

Mr. Mazza asked the status of the enforcement issues regarding wineries that are not reporting sales to the PLCB or to the PWMRB. This information was discussed at the last board meeting and Ms. Snyder was going to reach out to Mr. Duer and the PLCB to schedule a meeting. Mr. Duer was not informed regarding this issue but would follow-up with Ms. Sheffield to discuss at a later date.

Board members discussed the reoccurring issues with the online reporting system. The PLCB did move the link on their website which created some of the issues. Anyone who is having issues with the reporting system may contact Ms. D'Angelo so she can inform IT.

DELINQUENTS

Ms. Sheffield stated that there are two delinquents from 2013 and six delinquents from 2014. There are three delinquent wineries from 2014 that owe over \$100. Letters were sent under the Bureau Director's signature on April 28. Delinquent wineries are to receive one warning letter and then the information is given to the legal office to file at the district justice.
