Minutes of the March 18, 2014 Board Meeting – Conference Call

Public notice of the March 18, 2014 Pennsylvania Wine Marketing and Research Program Board meeting was given on March 13, 2014, as stipulated by the Sunshine Law.

CALL TO ORDER

Mario Mazza, Chairman, called the meeting to order at 11:09 a.m. Board members in attendance (in addition to Mr. Mazza) included John Landis, Joanne Levensgood, Elwin Stewart and Karl Zimmerman. Also attending was Jennifer Eckinger, Pennsylvania Wine Association; Brook Duer, Pennsylvania Department of Agriculture; and Samantha Snyder, Pennsylvania Department of Agriculture. Jennifer D'Angelo attended and recorded the minutes.

MINUTES

Minutes of the February 18, 2014 meeting were emailed to Board members for their review in advance of the meeting.

ASSESSMENT REPORTS

Ms. Snyder reviewed the Summary of Assessment Forms 2013 Year-To-Date. As of March 12, 2014, \$126,907.10 has been collected from Pennsylvania wineries. There were 258 licensed wineries, 88 licensed wineries with no sales assessments reported, 170 producers with sales assessments and the number of producers paid was 137.

Ms. Snyder then reviewed the Assessment Income Analysis by Quarter. In the first quarter of 2013, \$28,579.94 was received; \$34,780.40 was received in the second quarter, \$14,607.68 was received in the third quarter of 2013, \$48,939.08 for the fourth quarter of 2013 was received for a total of \$126,907.10 collected. \$44,137.34 was received so far in the first quarter of 2014.

There being no further business, the meeting was adjourned at 12:28 p.m.


