CALL TO ORDER

Ms. Young discussed the Potato Assessment Report as of December 31, 2020, prepared by Holly Zarefoss indicating a total collection amount of \$39,328 for the 2018 marketing season, \$6,636 collected from 14 growers with zero (0) delinquent remaining; a total collection amount of \$40,557.92 for the 2019 marketing season, \$18,163.92 collected from 18 growers with zero (0) delinquents and \$37,806.80 collected for the 2020 marketing season, and \$10,456 from audit payments with two (2) delinquents.

PENNSYLVANIA REGIONAL POTATO GERMPLASM EVALUATION PROGRAM

Dr. Xinshun Qu/Michael Peck, Researchers, Penn State University, presented before the Board for discussion of the Pennsylvania Regional Potato Germplasm Evaluation Program. Mr. Peck

talked about the different varieties grown at three different locations, including among other locations Erie County, Lehigh or Northampton County and Rock Springs, Centre County. Objective details were provided. Board members were referred to the submitted proposal for review. Board members had questions.

POTATO GROWER LETTER/TIMELINE DISCUSSION

Mr. Andrews referred to a letter from Keith Hilliard for further discussion of whether the Board felt the argument of the timing of assessments should be considered. Ms. Zarefoss explained that the letter he was probably referring to was sent out October 8, 2020, which included a copy of claims that would have been filed for nonpayment. She indicated the claim had been paid. Board members discussed several options, including delaying the first notice a couple months and changing the due date on the notice,
