PENNSYLVANIA WINE MARKETING AND RESEARCH PROGRAM SPECIAL MEETING MINUTES of the May 23, 2023 Board Meeting

WINE TRAIL PROJECTS

Mario Mazza recapped the issue at hand regarding allocation of funds to wine trail projects and the feedback that will be given to the applicants. He reviewed the options provided in the meeting packet and opened the floor for discussion.

The Board and Scott Neely discussed how wine trails will be funded through PWA's marketing campaign matching project for wineries and wine trails. There was discussion on whether PWA should fund individual wineries or all wineries as a group. The final position taken by the Board is that they would encourage the individual wine trails who applied for Act39 funds to share their proposals with PWA. They would also encourage PWA to wrap these proposals into their grant program, allowing the Board to support these trails through PWA.
