# PENNSYLVANIA MALT AND BREWED BEVERAGE INDUSTRY PROMOTION BOARD Minutes of the September 15, 2020 Skype Board Meeting

#### CALL TO ORDER

William Brock, Chairman, called the meeting to order at 9:06 a.m. Board members in attendance via conference call included Sean C. Casey, Frank Pistella, and Jeffrey Reeder.

Christian T. Lampe was not present at the commencement of the meeting.

Michele Meloy Burchfield was absent.

Also in attendance via conference call were Patrick Andrews, Chief, Market Development, PA Department of Agriculture; and Char Riley, Department of Agriculture Liaison PDA and ACMA.

#### **REVIEW OF BEER GRANT EXTENSIONS**

Beer 2 National Beer Museum extended to 12/17/2020

Beer 2 Cumberland Area Economic Development Corp. extended to 1/7/2021

Beer 2 California University (not yet reviewed, but it looked like they want another 6 months which if approved, would take them to the end of September 2021 on a project started in July 2019 that has yet to submit a single invoice toward the \$72,500 grant.)

Beer 3 Pittsburgh Brewers Guild extended through 7/31/2021.

Patrick Andrews, Chief, Market Development, PA Department of Agriculture, discussed information related to BOP extensions and was informed to email the resource account for PLCB. They did not get a response but were encouraged by Mr. Andrews to resubmit the email.

Chairman Brock discussed an email from PLCB about the grant status. He felt it was somewhat problematic that some applicants he felt were pretty good had not been returning or

submitting reimbursements. Mr. Andrews commented that one area that Penn State struggles with is their invoicing. Chairman Brock commented the money was being allocated, but it was not going where it should.

Mr. Casey noted he had suggested to Elizabeth Brassell creation of a single-page summary or checklist be provided to grant recipients regarding the key action on how to work with PLCB on invoicing and billing. It was his understanding that PLCB was working on such a list.

Chairman Brock suggested sending out a one-page sheet of a few questions so that applicants can update their status and the information be inserted onto a spreadsheet for the Board to review. He requested to be informed if the grants were successful, what worked, and what did not.

There was discussion regarding staffing information that would be passed on to the PLCB for review.

Mr. Andrews noted a balance of \$143,327.45 remains, which could go up once unspent grant funds are determined. There was further discussion.

Mr. Andrews noted that one of the applicants not in the current motion to fund is ranking higher than an applicant the Board has thought about funding, that applicant being Douglas Clayton, Hop Stop Farm, Increasing the efficiency and quantity of harvesting hops in Northwestern PA by purchasing a Wolf Harvester. Board members discussed the application. Mr. Lampe reduced his overall score on that to 42.

Mr. Casey noted on the record that the Department of Agriculture and the Board worked through a very difficult period over the past year trying to determine fund grants.
