- Documentation showing industry experience for the selected ITQ categories (number of years dependent on ITQ category)
- Counties you are able to serve (for applicable ITQ categories)
- Additional qualifications may be requested for certain ITQ categories

The Commonwealth will review each submitted prequalification to determine whether the supplier meets the minimum requirements of the applicable ITQ contract. If the minimum requirements for the ITQ contract are met, the supplier will be awarded an ITQ contract.
