## INSTRUCTIONS FOR COMPLETING THE SEED LICENSE APPLICATION

1. Check the license block at top of page. A distributor is the person(s) whose name and address appears on the container, package or labeling. The addendum box is for a primary distributor who already has a seed license and wishes to add additional distributors. Each name and address that appears on the label will be required to obtain a Seed License.
2. Type or print business name and address. This should be the name and address of the distributor that appears on the container/package or label. Include county only for PA licensees.
3. Complete the additional licensee(s) section for multiple distributors, list all names and addresses appearing on label or package of the seed. Otherwise, indicate *SAME AS ABOVE*. Include county only for PA licensees.
4. Complete the *Mailing address if different* section ONLY for firms that wish to receive all correspondence related to this license other than the licensee (company headquarters, private labeling firm, toll millers, etc.).
5. A responsible officer of the business must sign the application and indicate his or her title.
6. Submit license fee of \$25.00 per distributor (each name and address).
7. Make check or money order for proper amount payable to the:
