We offer 10 cent superfecta and 50 cent pick 4 wagering.

Racing and Mutuel Format

Parx Racing will continue with the fast official. In addition, simulcast races will be used as extra races where conditions permit.

Parx Racing will conduct either eight (8), nine (9), ten (10), eleven (11) or twelve (12) live race programs, as circumstances warrant, with the mutuel formats listed below. Superfecta's will be conducted daily where appropriate.


