Amusement ride/attraction owners/operators must file with the Department this registration and itinerary form prior to operating in Pennsylvania. In completing this form, the owner is responsible for all information as to completeness and accuracy. Also required is a Certificate of Insurance (COI) verifying coverage in the required amounts with a company authorized to do business in the Commonwealth. **Failure to do so will subject such owner or operator to the penalty as provided by law.**
